# ASUN Guidelines for Writing a Constitution for Recognized Organizations

This is a sample constitution to help assist in developing your own document. The sections in yellow must be included.

### Article I: Name of Student Organization

x State the name of our student organization and any surnames your organization will be referred to.

#### Article II: Mission Statement

x State the mission of your student organization. What does your organization hope to accomplish?

### Article III: Membership

- x State the requirements
  - o In every organization, there must be, at minimum, a basic membership.
    - f This means any undergraduate student can be a member of your organization without paying dues, having a GPA/ credit requirement, etc.
    - f Basic members cannot be removed from out of the club.
  - o If your organization chooses, there can be active members brigas y variation of this.
    - f This is where you can include responsibility to pay dues, attendance requirements (events or meetings or both), voting rights, etc.
    - f You may evoke active member status of a member, demoting them to a basic member, but you may not remove them altogether.
- x Must include the ASUN Statement of Noniscrimination
  - o "[Organization] does not discriminate with respect to membership on the basis of race,color, creed, religion, national origin, age, sex, gender identity, socioemic status,physical or mental impairment, or sexual orientation"

# Article IV: Officer Titles and Responsibilities

- x List the title of each officer
  - o Be sure to note if any officer is a shared position, i.echairs
- x List the general responsibilities of each officer

#### Article V: Officer Election or Selection Process

- x Define who is eligible for holding office
  - o I.e. all members, active members only, etc.
- x Describe the process to elect or select officers each term
- x Describe the general date when election or selection must be completed
  - o I.e. by Week 5 of Sprin@uarter
- x Describe the general start and end dates for officer terms
  - o I.e. starts Week 5 of Spring Qtter andends Week the following Spring Quarter

# Article VI: Voting Eligibility, Quorum, and Majority

- x Define the eligibility requirements to be an eligible voter
  - o This should also be mentioned within your definitions of membership variations
- x Define whatconstitutes a quorum in order to vote
  - o What percentage or fraction of your eligible metoners need to be present to vote?
- x Define what is considered a voting majority

### Article VII: Amendments

- x Describe the process to propose any changes to the consti**pution** or to the student organization in general
- x Describe the process to ratify (approve) any proposed changes
- x Describe the general date when retifichanges will go into effect
  - o I.e. the day after ratification isomplete
- x Describe the general date when ASG will be informed of ratified changes

- x State the frequency of officer meetings
- x State the frequency of membership meetings
  - o I.e. general meetings
- x Describe the general flow and procedures of these meetings

- x List the name of each committee
- x List the general responsibilities of each committee
- x Describe the process itoin each committee
